AN ORDINANCE approving the migration of data and three years of cloud service for the Munis Accounting, Purchasing, Human Resources and Payroll software at a total cost of \$1,408,135 from and through Tyler Technologies, Inc. by the City of Fort Wayne, Indiana,

WHEREAS, Munis accounting, purchasing, human resources, and payroll software is crucial to the continued operation of the City of Fort Wayne and City Utilities,

WHEREAS, migration away from a self-hosted version of Munis accounting, purchasing, human resources, and payroll software will eliminate the ongoing expenses of hardware purchases, hardware maintenance, software maintenance and security maintenance necessary for the continued operation of Munis software for the City of Fort Wayne and City Utilities,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the purchase of migration services and three years software as a service fee for the Munis software from Tyler Technologies, Inc for a total of cost to the City of \$1,408,135 is hereby approved in all respects. That said Yearly Maintenance will be used to ensure the proper accounting of the City's fiscal operations.

SECTION 2. That the City is authorized and directed to take all action necessary for the purchase of this system by and through Tyler Technologies, Inc.

SECTION 3. That this Ordinance shall be in full force and effect from and after its passage and any and all necessary approval by the Mayor.

Subject: Tylertech Software as a Service

Members of City Council:

This ordinance is to authorize the purchase of migration services and three years of cloud service for the Munis Accounting, Purchasing, Human Resources and Payroll software at a total cost of \$1,408,135 from Tyler Technologies, Inc. The annual recurring cost of the software as a service is \$477,782 per year.

The City, County, and Utility's on-going strategy for IT services to move local, in-house computer systems to cloud based services. This purchase is a direct implementation of that strategy.

The rationale for this strategy is based on these factors:

- Eliminate the on-going expense of buying, upgrading, and maintaining local computer servers, storage, and backups.
- Eliminate the on-going expense and disruption of upgrading and testing new releases of software.
- Eliminate the risk and on-going expense of defending a local computer system against on-going security attacks.

While the use of software as a service reduces the risk of successful security attacks, it does not eliminate them. It's possible that any vendor may be breached. However, a severe local breach would compromise every computer system we run locally, while a vendor's would be limited to one system.

If the software failed, we would rely on support from Tyler to produce financial reports, create purchase orders, pay bills, and most critically, create payroll checks.
