14	Township 30 North, Range 13 East, Allen County, Indiana, containing 1.26 acres, subject to road rights-of-way and easements.
15	Together with:
16	Part of the Northeast Quarter of Section 5, Township 30 North, Range 12 East, Allen
17	County, Indiana, more particularly described as follows:
18	Beginning at a point on the East line of the Northeast Quarter of Section 5, Township
19	30 North, Range 13 East, Allen County, Indiana, said point being 220.0 feet South of the Northeast corner of the Northeast ¼ of Section 5-30-13; thence South along the
20	East line of the Northeast 1/4 of Section 5-30-13, a distance of 95.0 feet: thence
21	Westerly a distance of 250.2 feet to a point on the East line of Lot numbered 5 in Greenview Addition, said point being 325.0 feet South of the North line of the
22	Northeast ¼ of Section 5-30-13; thence North along the East line of Lot numbered 5 in Greenview Addition, and parallel to the East line of the Northeast ¼ of Section 5-
23	30-13, a distance of 105.0 feet; thence East parallel to the North line of the Northeast
24	1/4 of Section 5-20-13, a distance of 250.0 feet to the point of beginning containing 0.57 acres, subject to road rights-of-way and easements.

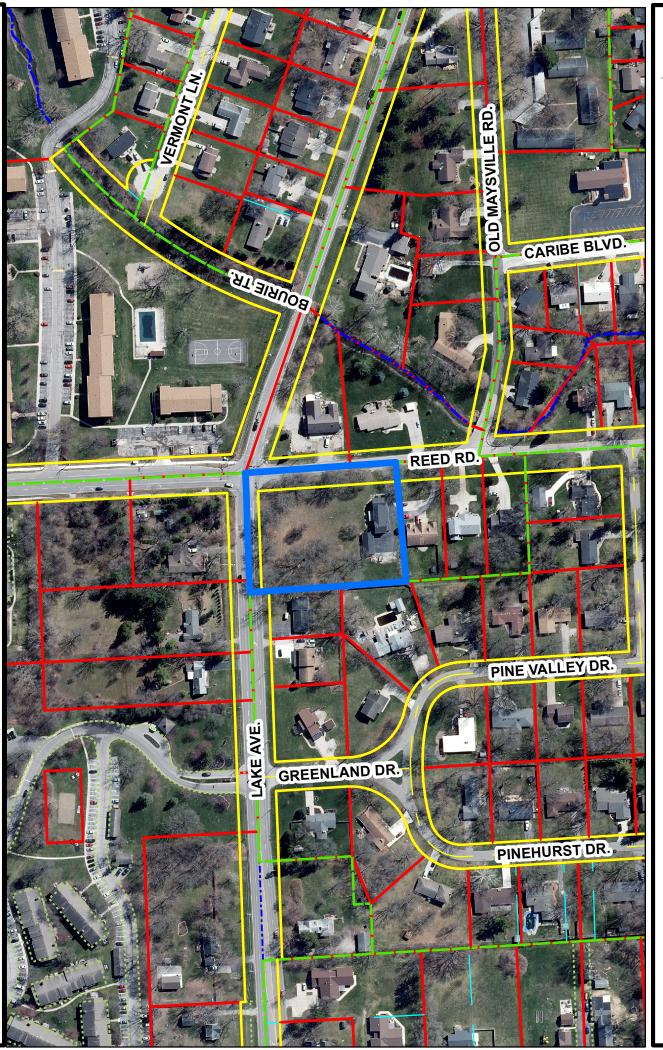

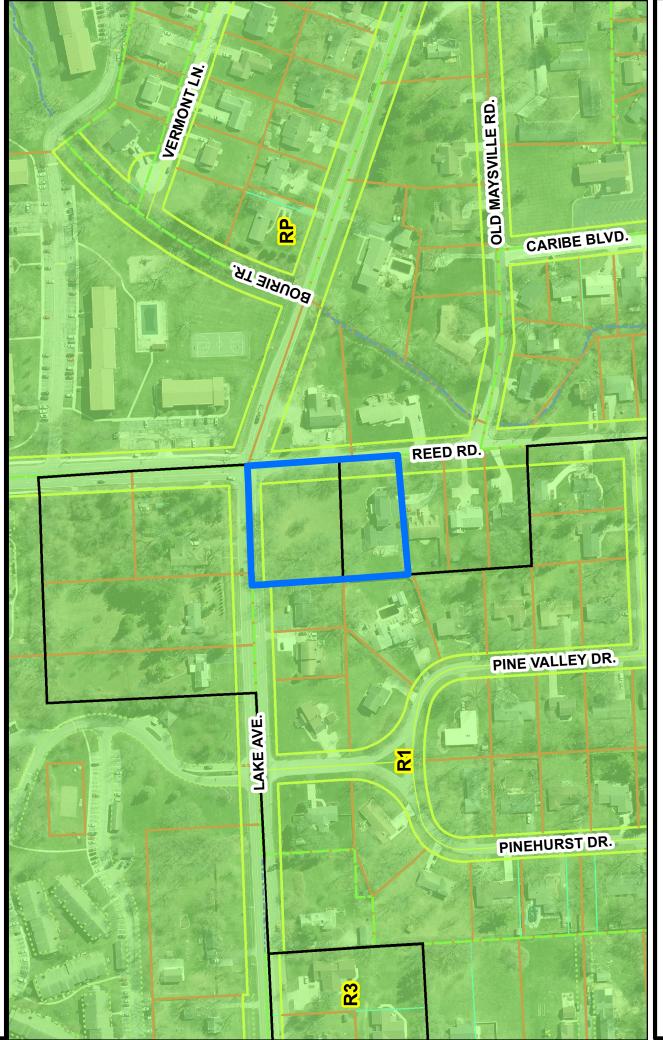

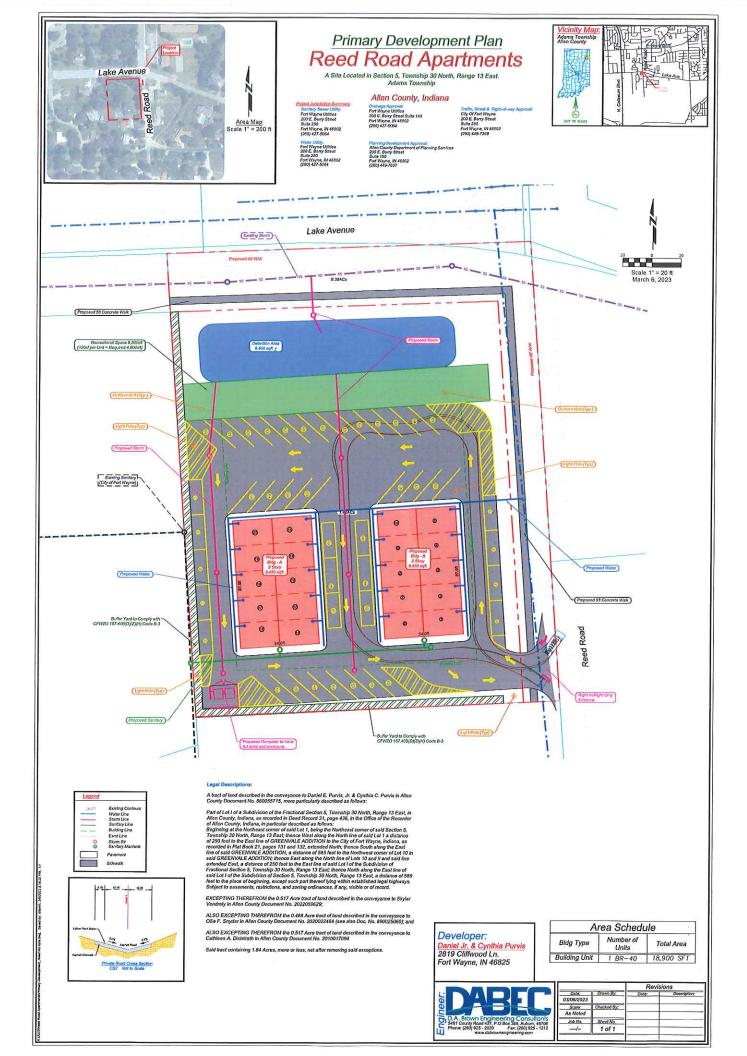
