A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA, APPROVING THE USE OF LOCAL INCOME TAX REVENUES FOR REIMBURSEMENT BY THE FORT WAYNE REDEVELOPMENT COMMISSION OF STREETSCAPE COSTS FOR THE ASHBERRY PROJECT

WHEREAS, on September 14, 2020, the City of Fort Wayne

Redevelopment Commission (the "Commission") approved an economic development
agreement (the "Agreement") with Ashberry Eight, LLC and Raze 222, LLC

(collectively, the "Developer") for development and construction of the Ashberry project,
which consists of a 7-story building containing 80,000 square feet of commercial space
and approximately 383 structured parking spaces at an investment of more than \$43.4

million, located between Main Street, Maiden Lane, and West Berry Street in downtown

Fort Wayne (the "Project"); and

WHEREAS, as part of the Agreement, the Developer agreed to design, construct and install streetscapes on the sides of the project facing Berry, Maiden, and Main (the "Streetscapes"), and the Redevelopment Commission agreed to reimburse the Developer for those costs; and

WHEREAS, the Developer has completed the Streetscapes and has requested reimbursement for the actual cost of the Streetscapes in the amount of Three Hundred Ninety-Five Thousand Eight Hundred Seventy-Seven and 37/100 Dollars (\$395,877.37), as more particularly described in attached Exhibit A; and

WHEREAS, the Commission has requested approval from the Common Council for the expenditure of LIT funds in the aforesaid amount to reimburse the Developer for the cost of the Streetscapes.

**TITLE OF ORDINANCE.** A Resolution of the Common Council of the City of Fort Wayne, Indiana, Approving the Use of Local Income Tax Revenues for Reimbursement by the Fort Wayne Redevelopment Commission of Streetscape Costs for the Ashberry Project

**DEPARTMENT REQUESTING RESOLUTION.** Redevelopment Department

**SYNOPSIS OF RESOLUTION.** As part of the Economic Development Agreement for the Ashberry / Star Bank project, which is a 7-story building with 80,000 square feet of commercial space and approximately 383 parking spaces, the Redevelopment Commission agreed to reimburse the developer for costs associated with the construction of streetscapes surrounding three sides of the project. This resolution would approve use of \$395,877.37 of LIT funds for reimbursement.

**EFFECT OF PASSAGE.** The Economic Development Agreement for the Ashberry / Star Bank project required that, upon completion and acceptance by Public Works of the streetscapes surrounding the Berry, Maiden, and Main sides of the projects, the Redevelopment Commission would reimburse the developer for the cost of the streetscapes. The developer has completed its obligations under the Agreement, including adhering to public bidding requirements of the City and State, so to fulfill its own obligations under the Agreement, the Commission must reimburse the Developer the aforesaid amount.

**EFFECT OF NON-PASSAGE.** Without approval of this Resolution, the Commission would need to identify another source for payment of this obligation, or risk breaching the Economic Development Agreement. This anticipated expenditure has been included in the City's approved 2023 LTT budget, so failure to pass this Resolution could have a downstream effect on other projects if another funding source needed to be identified.

The Community Development Division is requesting the Common Council's consideration and approval of a resolution authorizing the Redevelopment Commission to use \$395,877.37 from LIT funds to reimburse the developer of the Ashberry/Star Bank project for the costs associated with the installation of streetscapes on three sides of the project.

The Ashberry/Star Bank project consists of a new 7-story, \$43,400,000 building located between Berry, Maiden, and Main in downtown Fort Wayne. According to the Economic Development Agreement for the project, the Commission is obligated to reimburse the developer for the cost of the streetscapes upon substantial completion of the building and acceptance of the streetscapes by Public Works into the infrastructure system. Both of these conditions have been met.

It's important to note that the cost is significantly lower than the \$750,000 budgeted for the project in the City's approved LIT budget.
