8                   WHEREAS, Common Council of the City of Fort Wayne adopted a Comprehensive Plan for the  
9                   City of Fort Wayne (All-in-Allen), in accordance with the statutes of the State of Indiana; and,

10                   WHEREAS, on December 15, 2025, the Fort Wayne Plan Commission initiated the  
11                   amendment of the Comprehensive Plan to adopt the Future Growth & Development map  
12                   updates; and,

13                   WHEREAS, the Common Council desires to amend Section 153.05 to recognize the  
14                   amendment of the Future Growth & Development map update to the Comprehensive Plan which  
15                   will repeal and replace the existing Future Growth & Development map; and

16                   WHEREAS, the City Plan Commission, in accordance with the Planning Statutes of the  
17                   State of Indiana held a public hearing on the Amendment to the Comprehensive Plan; and,

18                   WHEREAS, this ordinance is to establish an amendment to the Comprehensive Plan to  
19                   include updated Future Growth & Development maps based on issues that have come up since  
20                   the effective date of the All In Allen Comprehensive Plan, March 13, 2023.

21                   NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF  
22                   FORT WAYNE, INDIANA:

23   SECTION 1.   Section 153.05 of Chapter 153 (Planning & Development) of the City of  
24                   Fort Wayne is amended by repealing and replacing the Future Growth & Development map in the  
25                   All In Allen Comprehensive Plan.

26   SECTION 2.   That this Ordinance, after its passage and approval by the Mayor, shall  
27                   be in full force and effect starting on April 8, 2026.

A summary of the proposed All In Allen Comprehensive Plan Future Growth and Development Map updates is below; the proposed effective date is April 8, 2026.

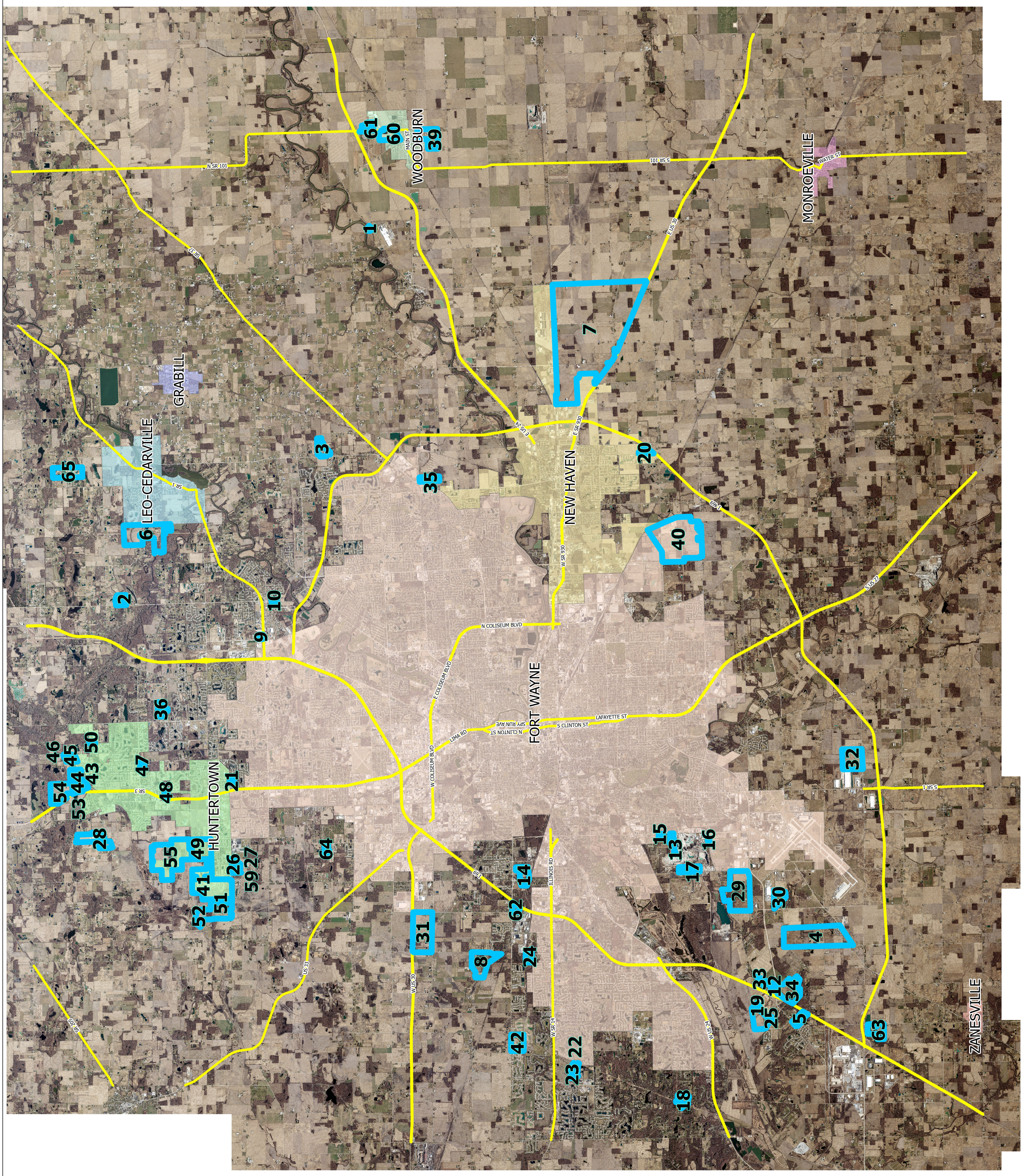
The proposed All In Allen Comprehensive Plan Future Growth and Development Map updates developed from the following sources:

- Rezonings: Staff analyzed the Plan Commission Rezoning over the last several years and compared them with the map to identify any discrepancies.
- Annexations: Staff analyzed all Annexations in Allen County over the last several years and compared them with the map to identify any discrepancies.
- Subdivisions: Staff analyzed the Plan Commission Subdivision Plats over the last several years and compared them with the map to identify any discrepancies.
- Stakeholder Meetings: Staff met with developers, builders, economic development agencies, utility agencies, school district representatives, and jurisdiction representatives to ensure the map was update to date with current development trends.

The Future Growth and Development Map of Allen County, Fort Wayne, Huntertown, and Woodburn jurisdictions will be amended as part of this Future Growth and Development Map Update.
